

#### **Juvenile Justice**

Klaras Center for Families (KCF), the provider for Child & Adolescent Services for HOTBHN, has multiple Specialized Juvenile Justice Programs. Each program serves high-risk juveniles aged 10-17 with mental and behavioral health concerns and justice system involvement.



#### Texas Corrections Office on Offenders with Medical and Mental Impairments (TCOOMMI)

TCOOMMI, in collaboration with the Texas Juvenile Justice Department (TJJD), is a case management program designed to address youth's mental health needs and juvenile justice involvement to rehabilitate youth and deter further involvement with the criminal justice system, which the HOTBHN–KCF and Bill Logue Juvenile Justice Center partner to manage this voluntary program with youth that reside within McLennan County.

The youths and the families' needs, as they pertain to criminogenic risk and clinical need, are addressed through intensive and collaborative wraparound service models that outline ongoing support systems and resources for the family through aftercare.

### Commitment Reduction Program (CRP)

CRP is a collaborative program between HOTBHN–KCF and Bill Logue Juvenile Justice Center that is court-ordered and designed for youth who have juvenile justice involvement and reside within McLennan County.

The goals for this program are reducing delinquency, increasing offender accountability, and rehabilitating juvenile offenders through comprehensive, coordinated community-based mental health treatment.

The program is structured to provide intense wraparound programming to juveniles with behavioral health challenges who are in danger of being committed to TJJD or another out-of-home placement.

#### **ENCIRCLE**

Encircle Project is a collaborative program between HOTBHN–KCF and Bill Logue Juvenile Justice Center that is voluntary and designed for youth who may or may not have juvenile justice involvement and having difficulties at school and who are placed at or are transitioning back to their home campus from, McLennan County Challenge Academy (Juvenile Justice Alternative Education Program––JJAEP) or G.L. Wiley Opportunity Center (District Alternative Education Program––DAEP).

The goal of the program is to reduce the high recidivism rate that youth transitioning from DAEP and JJAEP back to their home campuses experience by facilitating a smooth reintegration process.

## Juvenile Justice Transition Team (JJTT)

JJTT is a specialized KCF program designed to provide intensive mental health services to highrisk youth transitioning from TCOOMMI, CRP, ENCIRCLE and TJJD into less intensive ongoing services; youth with juvenile justice involvement that may or may not be discharging from substance use or residential treatment centers into a HOTBHN service area may also be served by this program.

The program provides a step-down in intensity and frequency of services provided in TCOOMMI, CRP, ENCIRCLE, and/or other specialized programs, thereby reducing recidivism and regression into the juvenile justice system with the goal of continuing to support their ongoing success within the community, at school, and in their home environment.



#### **Bill Logue Juvenile Justice Contract**

The 795 Contract is designed for youth who are involved and referred by the McLennan County Bill Logue Juvenile Justice Center who need psychiatric services only and who are not currently in services with Klaras Center for Families.
