It was identified and communicated to Cumming Group representative at site visit that, in order to perform the work mentioned above, work associated with framing, HVAC, electrical, and plumbing will be required to properly perform said work and to meet code requirements. Please confirm that it is not assumed that the general contractor would be responsible to perform this work and that the general contractor is only responsible for work confirmed as listed in scope of construction documents and RFP scope on page 10 of RFP packet.
